# Visiting the website

When you visit our website, we can log your IP address. We can also log the type of web browser you are using, the operating system you are using and the domain name of the website from which you reached our website. The data is collected for demographic purposes, e.g. in order to determine the geographic location of visitors and the time they spend on our website. We do not draw any conclusions about you with the use of this information. The logging of this type of data enables us to manage our website, diagnose server problems, analyse trends and statistics and thereby offer you better customer service. The data is also required in order to provide prosecuting authorities with the information necessary for prosecution in the event of a cyberattack. Our authorisation to the aforementioned data processing results for one from our legitimate interest in operating a website and a web server (Article 6(1)(f) of the General Data Protection Regulation). With regard to the use of data for the provision of data to prosecuting authorities, the authorisation is based on the fact that in the event of a cyberattack we are obligated to provide data to prosecuting authorities (Article 6(1)(c) of the General Data Protection Regulation).

The data will not be disclosed to third parties, with the exception of our hosting service provider which hosts the website on our behalf.

We plan to store the personal data specified above for a period of 7 days and then to erase it afterwards.

We do not intend to transmit data to third countries outside of the European Economic Area.

#### Cookies

When you visit our website, we can send 'cookies' to your computer. A cookie is a small text file or a data fragment which the website you are visiting can store on your computer. Cookies themselves do not contain any data that can be used to personally identify the user. However, if you provide us with personal data (e.g. by registering for one of our Internet services or a password provided by us), this information can be linked with the data stored in the cookie. There are two types of cookies. The first type stores the data for a longer period on your computer and the data are also preserved after the computer is switched off. Such cookies are used in order to inform the user which data on the website have been updated since the user last visited, for example. The second type of cookies are what are known as 'session cookies'. These session cookies are temporarily stored on your computer during your visit to the website. A language selection can thereby be maintained, for example. Session cookies are not store on your computer for a longer period of time but rather are deleted when you close your web browser. We can also contract third parties to log or process cookies data.

#### We can use cookies for various reasons, e.g.:

Google uses the collected data and information on our behalf to evaluate the use of our website and to provide online reports, which show the activities on our websites, and to provide other services concerning the use of our website for us, among other activities.

Google Analytics installs a cookie on your computer. We explain what cookies are again in detail below in section 4. The installation of the cookie enables an analysis of the use of our website. With each visit to one of the individual pages of this website, the web browser on your computer is automatically triggered by the respective Google Analytics component to transmit data to Google for the purpose of web analytics. During the course of this technical procedure, on our behalf Google gains knowledge of personal information, such as your IP address, which serves Google to understand the origin of visitors and clicks, among other activities.

The cookie is used to store personal information, such as the access time, the location from which the access was made, and the frequency of visits to our website by you. # **Google Fonts**

External fonts from Google Fonts are used on these web pages. Google Fonts is a service of Google. If you make use such settings or plugins then the map display of Google Maps will not be displayed at all or will only be displayed after you have given explicit approval; it is only then that the aforementioned data transmission to Google will occur.

We do not store any personal data within the context of Google Maps.

Personal data is not transmitted to other recipients.

During the course of this technical procedure, YouTube and Google gain knowledge of what specific sub-page of our website was visited by you. If you are logged in at the same time on YouTube, YouTube detects which specific sub-site of our website was visited by you each time you visit the website. This information is collected by YouTube and Google and associated with your respective YouTube account.

YouTube and Google will receive information through the YouTube component that you have visited our website if you are logged into YouTube at the same time when you visit our website; this occurs regardless of whether you click on a YouTube video or not. If you do not wish to transmit personal data to YouTube, you can prevent such transmission by logging out of your YouTube account before accessing our website.

You can also prevent the establishment of an automatic connection at any time by adjusting the settings of the web browser you are using accordingly; our website will then still be able to be used, albeit without the videos.

Personal data is not transmitted to other recipients.

# Online shop

Within the framework of our online shop we offer you the ability to place orders. The use of the online shop is not required for the use of the rest of our website. If you use our website then we will collect your personal information (title, name), contact information, billing and delivery address as well as information about the purchased product and your selected method of payment (credit card, PayPal, SEPA transfer).

We use these data for the processing the contract concluded with you as well as for the delivery of the ordered goods (Article 6(1)(b) of the General Data Protection Regulation), to fulfil the legal obligations which apply to us (e.g. obligations to preserve data under commercial law or tax law; Article 6(1)(c) of the General Data Protection Regulation) and potentially for marketing purposes in our legitimate interest (Article 6(1)(f) of the General Data Protection Regulation). Data transmission to other recipients is carried out to our hosting service provider which hosts the website on our behalf, any service providers we use on our behalf and at our instruction, payment service providers and shippers involved by us. Recipients can also include authorities (e.g. revenue authorities).

We plan to store the data specified above for a period of 10 days and then to erase it afterwards.

We do not intend to transmit data to third countries outside of the European Economic Area.

## Your rights

According to the provisions of Articles 15-20 of the General Data Protection Regulation, you have the right to obtain information about the personal data being stored about you. You also have the right to obtain the correction, erasure or restriction of processing of the personal data stored about you.
